That was an awesome thing, considering I know a lot of people have struggled getting dental coverage, and at times dental coverage was not possible considering Covid shut down some dentist appointments for a time. So, this will hopefully alleviate some concerns and provide much needed increase to amount. Other updates stem from finance committee, will come up to board eventually, today we just met

After discussion with business manager and the President, we have decided to suspend the fee for the menstrual hygiene initiative for Winter 2021 semester. Lastly, I had a meeting with multi-faith resource team, moving forward they are working on a policy that will allow them to advise the CSA clubs office on accreditation applications from faith-based clubs. So that will make accreditation process smoother. We will be doing a similar process with the Wellness Centre regarding mental health-based clubs. That is it for me.

We had fall convocations day, it was a video stream, I was slightly disappointed, but it is what it is. In general, I would be happy to answer questions on my report, but the only thing that hasn't been touched on is just concerns from students around Lockdown browser, it is an ongoing issue I am trying to address, and basically try to convince Professors that it is not a great way to test people. One concern is privacy and another major concern is issue of racial bias in Respondus, there is some reports of racialized students and people of colour not being recognized properly and that has all sorts of issues, that is one thing I am currently working through right now.

Given that a majority of the folks that participated in the survey had indicated that council should be larger or the same size, I find it really troubling that consultants have proposed to decrease number of councillors on city council, especially considering that Guelph's population is actually projected to increase by 200,000 people in the next 30 years, so it actually makes no sense to decrease the number of councillors representing citizens. There will be meeting happening November 5th, where final vote will take place. My motivation is to advocate for greater representation rather than less.

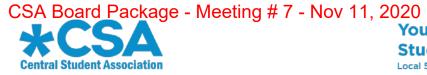

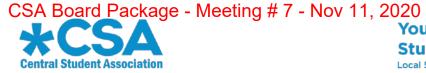
Committees:

CSA/GSA Health & Dental Plan Committee

The committee met on Thursday, November 5th to discuss the Health plan referendum question to be created for the Winter 2021 General Election. As a reminder, the committee voted to hold a referendum question surrounding whether the health plan should continue as a universal plan, or if it should move to an opt-out system similar to the dental plan. Additionally, the committee reviewed opportunities to increase coverage in certain areas, especially compared to other post-secondary institutions in our area. The committee is also looking to update the coverage amounts in relation to inflation so students can receive the same level of coverage despite inflation's effect on the total cost of service.

Finance Committee

The finance committee is meeting weekly to meet deadlines we have set, especially whereas the budget has not been completed for the 2020-2021 year. We also are reviewing the financial status of the Bullring as the service has been impacted greatly by COVID-19 and the closure of campus. Reports and minutes will begin to be sent to the Board by the next board meeting as our first set of minutes were recorded, but not approved by the committee, on Wednesday, November 4th.



Policy & Bylaw Review Committee

PBRC met for the first time on Monday, October 26th, and created a working group to rework the Executive Evaluation Committee in light of the fact that the EEC was created in light of a different CSA structure, and is incompatible with current systems. It had also required too much of directors, making it infeasible. PBRC also received an updated HR Policy in relation to vacation days & personal emergency days (PEDs), and this was required for the CSA to comply with regulations on vacation & PEDs.

Petitions, Delegations, & Representations Committee

The PDR Committee met on November 2nd and November 6th to discuss applications received for the first Fall deadline of October 22nd. Recommendations as to funding will be reported to the Board once final decisions have been made in relation to all applications.

Chief Returning Officer Hiring Committee

The hiring committee completed its interviews on Tuesday, October 27th (see the hiring report included in this package), and made the final job offer on October 28th, to which the successful applicant accepted. The individual hired had been in the Assistant Returning Officer position, and therefore the decision was made to award the ARO position to the second highest scoring candidate according to our interviews. (See hiring report).

Services:

Bullring

The Bullring continues to operate with a reduced menu. On Friday, October 30th, a plan was submitted to allow for livestreams to be run from the Bullring so the CSA can ensure students' entertainment fees are spent as they should be. Additionally, a separate application included the addition of dine-in services with a maximum of 10 dine-in customers at any given time, with one seat per table as recommended by Public Health. Both the livestream and dine-in applications were accepted by the Vice Provost of Student Affairs during the week of November 2nd.

The deadline to report fee changes for W21 was October 30th at noon, and it was decided that the following fees would continue to be suspended into the Winter 2021 semester:

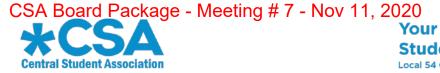

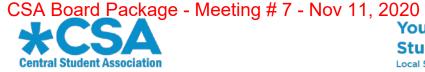

At the OACCTF, another TextbookBroke survey to determine the financial impact of course materials has been halted based on surveys focused on student wellness being higher priority. There is potential for questions related to course material costs due to financial wellbeing's relationship to overall mental health.

Academic Policies and Procedures Working Group

We last met on Oct. 23rd and will meet again on November 19th. The following potential changes are being contemplated and I would invite feedback: the Maximum Weight of Graded Component; policy on Maximum Weight of Single Course Component; policy on Academic Consideration; guidelines for Accommodation; policy on Retaking Passed Courses; calculation of Grade Point Average; policy on Late Adds; limits on Deferrals of Final Exams; and amalgamation of RTW Policies.

Student Rights and Responsibilities Committee

Met November 5th with the primary purpose of discussing fines for second offenses of not wearing a mask. A \$120 fine was agreed upon for repeat offenders, while first time "non-wearers" will be given a warning.

Student Energy Retrofit Fund

SERF is a legacy fund that no longer collects fees but has funds remaining that require consent from the CSA to be dispensed due to the funds originally coming from students. The athletic department wants SERF contributions to replace their current Zamboni (natural gas) with an electric Zamboni. After a review of the \$/tonne of CO2 emissions was completed, we agreed that this would be a worthwhile investment of the SERF funds. We are meeting again soon to discuss how the remaining funds should be allocated and spent, as they are not accumulating any interest right now and need to be spent.

Experiential Learning Ad-Hoc Committee

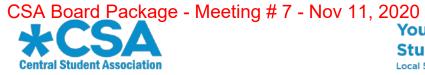
No updates since the last meeting.

Calendar Review Committee

Student Leaders and Admin Committee

SLAM met on October 14th (although I was not able to attend) and discussed GBSA recommendations as well as student health and safety as it relates to COVID-19. SLAM met on October 29th and I raised the issue of professors not enforcing mask wearing during in person classes, making students feel unsafe. This issue has since been addressed.

I also addressed the issue of racial bias within Respondus, stemming from insufficient facial recognition. I will be meeting with faculty and the U of G's Associate Vice-Provost to discuss this issue further in the coming days on the advice of Carrie Chassels

Student Help and Advocacy Centre

Discussions are ongoing regarding how to better promote the services that SHAC offers in the context of a pandemic. These services continue to be offered online and we are trying to ensure they are more fully utilized. Staff evaluations will be occurring in early November.
