As such, I would like us to educate ourselves on the impacts that colonization has had on Indigenous people and work towards dismantling its consequences, which Indigenous people are still suffering from today. In this way, we can work towards reconciliation with our Indigenous communities and help make Canada a just nation for everyone who calls it home.

5.7 Executive Updates

5.71. President

Nicole Walker: Hi everyone. I'm really excited about move-in day and O-week which we've already started getting involved in programming. We'll be on campus with our tie-dye swag so come say hi to us, we'd love to meet you in person. I've listed some of the programming that we've been working on over this summer which will be happening over the next three weeks. Please keep an eye on this to share with students. We've had some staffing changes over the summer, so you'll see a hiring report for an Assistant Returning Officer for our elections and Clubs Programming Coordinator, and we are finalizing the hiring for the PTC position. This is one of Earl's last Board meetings, but you'll see him at the inperson meeting. We've had a few resignations over the summer so we're looking to fill those. Our Executive had really great discussions over the summer with the Office of the President regarding a student perspective for providing feedback on the strategic plan. Those were really productive conversations about ways we can engage students to give more feedback that is student-given and have their voices incorporated. We're really happy with how collaborative this discussion has been.

The Sustainability Action Fund, which you will hear more about later in this meeting, is a fund based off a referendum that was passed in 2019. Essentially, it collects money from each student each semester for the next 30 years to align with the needs of climate change. The University matches the funding to make the campus more environmentally friendly. Our PDR meeting was moved because I was sick, and we'll move those applications and do our orientation in September. The UC Board did respond, but it didn't really change their decision or the outcome of the situation so we're going to move forward and be mindful in implementing changes to ensure the balance between the UC administration and students. The last thing that we've struggled with over the summer is the Food Bank in making sure we can support as many students as possible with a wait list of over 100 students. We've been trying to balance supporting as many students as possible and ensuring the Food Bank is sustainable because we only have so much money in our budget. To do this, as of September 1, we've changed it so that we are serving only students and not dependents and on a less frequent basis. We've provided those affected by this change with a list of resources and a food user guide where they can access a variety of supports in the community. We are also working with campus partners to address the systemic issue of food insecurity. I am happy to address any questions folks may have for me.

We will be hosting a by-election to fill the Board vacancies as well as the vacancy for the VP Student Experience. The Candidates' Package in its entirety is in your agenda package and I am open to any questions that you may have. I wanted to take the time today to share the specifics as we move back to in-person campaigning this semester as it is the first time in nearly two years. We are moving forward with more of a hybrid model with more opportunity for students to be talking about the election.

The breakdown of the important dates is shared in the document. It will open for nominations during the first full week of classes following O-week. We do have various things occurring in O-week to get students involved and engaged with the CSA. We will then have our campaigning period between Monday, September 26 and Monday, October 7 to allow for a week for promotional services to get

situated and give candidates time to understand the rules of campaigning. Voting takes place before just before the Thanksgiving break.

We added postering back into the package as students will be back on campus. The main point is our resource for what candidates can do to campaign because we've noticed in the past that students campaigning are unaware of these resources. This section describes what Promotional Services has to offer and what the turnaround is for them. The cost breakdown, how many posters that would get them, the turnaround, and the final due date are included. This will be discussed in further detail in future meetings. This is new to the package and can be found in both candidate and director versions to assist in the campaigning.

I am going to switch over now to the Nomination Package that was shared in the agenda package. The campaigning agreement is added to give examples and show the importance of campaigning and to emphasize how their support through campaigning is integral to the success of the election. Once we've broken down the importance, we've also included three points that we think would be beneficial for candidates to support their candidacy. These are things they will agree to when they are seeking nomination so they have an understanding of the expectations. We expect candidates to conduct a minimum of two class talks, to create a poster, and to share social media posts at minimum three times per week. This gets the word out there that they're running and to seek out students to vote in the election. We want to facilitate the experience for everyone in knowing what might help in reaching quorum. One main change in the package is the language change to reflect the fact that a student wishing to run in the election is not a candidate until the form is completed.

I am open to any questions in regard to the packages.

Nicole Walker, President, noted that Jewell will be on campus in person on Thursday, September 8. Those wishing to meet her may attend the resource fair in Branion Plaza and obtain election information. The President acknowledged the good work done by the CRO and remarked that the CSA is lucky to have her during this election cycle.

General Update:

Hi everyone, over the last few weeks, I've been busy with mostly the Student Memorial Service invitations and preparation, committee-startup for the Fall semester, as various committees plan to kick things off, and of course, Orientation Week, which I believe went exceptionally well. I have learned a few things that may be of interest to you including the fact that over 100 international students are unable to get to Canada at this time, due to their VISAs and so they may, unfortunately, face deferrals, if they can't get into DE courses. I've also heard a few concerns regarding course outlines and the requirements for these governing documents; the illness policy for example, is not required to be included but is one all students should be familiar with, and the late policy should of course be included but has been missing sometimes, so it may be worth looking into the procedure and departments that review the outlines before release and the release date itself.

We've certainly also been doing a lot of tabling to promote our by-election and the CSA in general, and it was really great connecting with students this way. I've received interest in the Accessibility Committee which might certainly be something we could look into starting again as I've been hearing some of the concerns from those with disabilities on campus and they don't seem to be too pleased with how the university has handled such concerns thus far.

Item 6.11.1 Orientation Week Report

Hello CSA Board of Directors,

I spent a large part of my summer planning the CSA's Orientation Week programming and I am happy to report that it was a smashing success for the CSA. We hosted or attended around 15 events over the course of the week.

I have provided a list of our events and my estimated attendance at each at the bottom of this report, but first, I would like to give an overview of the week!

The CSA's O-Week starts with START International the week before Move-in weekend. Through Student Experience's START International program, international students arrive on campus on the Monday evening the week before O-Week and they have three days of programming before other Residence Students move in. Jena-Lee and Mason hosted a trivia night for START International in Brass Taps for the first evening of programming. Then on Thursday, Mason and I attended the START Accessible resource fair for the students with accessibility accommodations who move in early. Thursday afternoon, we all went to the START International BBQ where there were a number of student groups with tables. This wasn't as big as other events throughout the week, but it gave the Exec a great first experience of tabling with our tent. Two reps from the Canadian Federation of Students, including our past VP External Affairs Kayla Weiler joined us to promote the ISIC cards (student discount cards).

The Executive did an amazing job at getting out there and repping the CSA all week long. They welcomed new students and their parents while directing traffic on Friday and Saturday of Move-in Weekend, they staffed our Pronoun Button and Resource tables at seven different events, speaking to thousands of new students over the course of the week, and I honestly couldn't have pulled off all of our events without their help. This year, as a hangover result of the COVID policies from the past couple years, Move-in Day for residence students was stretched over the course of three days rather than the one day of pre-COVID O-Week. For those who may not have lived in Residence, Move-in weekend is labour day weekend and starts on the Friday. On the Saturday night, this shifted move-in schedule gave us the opportunity to attempt a new program. We dubbed this Saturday evening program the CSA "Chill Vibes" Clubhouse.

At the CSA Clubhouse, we served mocktails provided by Brass Taps, Jena-Lee and I brought in our Nintendo Switch consoles and students played Mario Kart and Smash Bros in the Clubs rooms, a cover band duo played acoustic covers of popular songs while students had the opportunity to mingle in the UC Courtyard while drawing on tables covered in brown paper. For a rainy Saturday evening, it was a smashing success. Brass Taps served over 600 mocktails, and the last attendees drifted away just before 11 pm.

Sunday September 4 was the official start to O-Week after all residence students finished moving in at noon. The day was a grey one in the morning and there was a threat of rain, but we got lucky, and the rain held off for our biggest event of the week, the CSA Block Party! Block party this year was bigger than ever before. I worked with Hospitality, the Orientation Office in Student Experience and UC Services to create a veritable festival on Johnston Green. From 4:40 pm until 9:00 pm, we hosted a food truck rodeo, a pair of inflatable games (shoutout to Isha for booking these), and a number of lawn games and clubs. The cherry on top was the stage and live music that I spent the Lion's share of my summer working on. We featured four local Guelph acts, three bands that included current students or recent graduates (The Last Armada, SHEBAD, Excuse Me, and MoonBean).

Once dusk came, the food trucks rolled out and the inflatables came down and our main act took the stage. This year, we were pleased to host the Snotty Nose Rez Kids who flew in from BC just to play Block Party.

In the past, Block Party has been an event that Residence Life staff walk their communities to after their first meetings, but this year all attendees came voluntarily. I estimate that somewhere between 4000 and 5000 students enjoyed some aspect of Block Party over the course of the event. And as each band took the stage, the Executive made sure that the crowd knew it was the CSA who was hosting the event. (We have some great emcees on the Exec this year, especially Nicole!)

I stuck around until 4:00 am to guard the stage from the large congregation that gathered in front of Johnston Hall following the Block Party. In the future, I would recommend hiring an overnight security guard to watch the equipment.

The Monday of Labour Day weekend found us at Gryphfest, where the Exec staffed our table once again and reached a whole slew of students who hadn't had a chance to grab a button or chat the day before. We got some good feedback about what kinds of buttons to make for the future.

Monday evening was our first Sexy Bingo of the year. I hope it is a sign of things to come. We had a capacity of 450 in Peter Clark Hall, and we filled up almost ten minutes before the event started. I think I had to turn away between 800 and 1000 students who were still waiting in the hallway. Our next Sexy Bingo is September 22 (tomorrow) and Brass Taps was almost fully booked at the time of writing this report (September 16). The Exec hosted this Bingo and absolutely knocked it out of the park!

Tuesday was a pretty chill day. In collaboration with Hospitality Services, we brought back Subs and Clubs, the event at lunchtime where students can come grab a free lunch and then engage with CSA Clubs who have set up on Johnston Green. It's like a mini-Clubs Day with free lunch! We gave away just over 4500 sandwiches according to Hospitality.

Then, on Tuesday evening, we showed Minions: The Rise of Gru on an inflatable screen on Johnston Green. I estimated that we had somewhere between 600 and 700 students who came out to see the film! The experience was made better by the Executive who spent the event toiling away at an old school popcorn machine – because what's a movie night without popcorn!

On Wednesday, we attended Pep-Rally. I co-hosted the event while the Executive were in the stands and on the hill at Alumni Stadium evaluating the Hall Performances. Nicole had the privilege of announcing this year's Pep Rally winner! Wednesday is really when things start to wind down during O-Week.

Thursday, the first day of classes, was the day we really started seeing how many folks were back on campus. We attended the Resource Fair in Branion Plaza during the day, and Isha and I wrapped up the night by 8:30 pm after checking on the few events still happening (which was the earliest I had left campus since the previous Wednesday). Friday brought us our last two events! Jena-Lee spent the afternoon tabling on behalf of the CSA at Culture Jam in Branion, and – in collaboration with Residence Life – we brought the Hypnotist, Jeff West, back to campus. We had two instances of the hypnotist show, and both had an attendance of just over 300 students.
