**WHEREAS** thousands of Nigerians have been protesting SARS for the past several weeks, only to be met with increased violence from the police; and

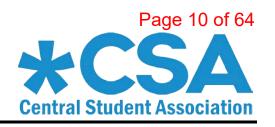
**WHEREAS** on October 20th, the Nigerian army and police officers fired into the crowd killing at least 12 protesters.

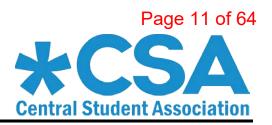

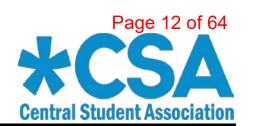

I want to begin by acknowledging that our gathering place, the University of Guelph, is on the ancestral lands of the Attawandron people, and the treaty land and territory of the Mississauga's of the Credit. Together we recognize the significance of the Dish with One Spoon Covenant to this land, which is a peace agreement between nations before the arrival of Europeans. This covenant is a characteristic of our collective responsibility to each other, and to Mother Earth, understanding that we should only take what we need leaving enough for others, and keeping the dish clean.

As we gather today, I ask each of you to recognize the significance of Orange Shirt Day. Recognize that Ontario alone had 17 residential schools that contributed to a genocide and ethnic cleansing on stolen land. The closest one to Guelph being the Mohawk Institute in Brantford, Ontario which was the first Canadian residential school to open in 1831.

I take this time to offer my respect to my Anishinaabe, Haudenosaunee and Metis brothers and sisters, as we continue to build a strong, authentic relationship with our settler neighbours. I want everyone to know and understand the importance of recognizing the land that you occupy where you learn and work, especially taking into consideration that many of us may not currently be residing in Guelph, and I encourage you to research the areas in which you occupy.

### 5.11.1. CSA By-Election Results – Fall 2020

Pete Wobschall, Policy & Transition Manager: I will share with you the unofficial results report. So, it was a challenging year because of Covid, we were concerned with the number of people we were going to get to vote. So, we did have to adjust to online and one of the things we did was amend the bylaw of the 10% to meet quorum. The total student population at time of election was around 21,363, some emails did bounce back, we assume those are students who left the University, which meant we had 21,333 total ballots towards quorum. Quorum is 10% of undergraduate population, which is 2,133, we actually had 1,957 ballots submitted which is 9.7% which is very close to 10% Quorum. which is surprising and quite impressive. This leaves us hopeful for Winter Semester election. Sean Mitchell was only one who ran for Academic Candidates, he got 79% of the votes, so he won the election of VPA. I have been very impressed with my interactions with Sean. In terms of Elections for directors, we did have two for the Lang School of Business At-Large Representatives, the total number of ballots sent at time of election was 3,881, quorum was 288 but don't forget the quorum bylaw was amended. We did have 323 ballots submitted which was 8.3% of undergraduate student population, which is again very close to the 10% quorum. We had two candidates who were both successful, Hayley and Jas. Hayley had 53% of vote and Jas with 37% of the vote. Quick summary of details, on first day of voting we got 1,097 votes which is up from last year, which is a good number during COVID. Tuesday it went down, Wednesday we did some outreach, which bumped up the voting, so we had 1,957 votes altogether. The president, the ARO, Assistant Returning Officer, and myself will be meeting to debrief on the election and we will create a report for it with recommendations for future elections, and we will provide a report to new CRO who will be hired soon. Patrick McCarthy who was our CRO resigned effective Friday October 2<sup>nd</sup>, it was on good terms he just had several other commitments, so he made the respectable decision to step away from the CSA because he knows it requires a lot of attention. Jewel Lindemann, is our ARO and she stepped up and did a wonderful job, we very proud of her.

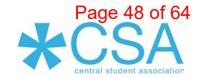

### CSA President Update: October 28th CSA Board Meeting

Hello Board of Directors,

I hope midterms & assignments are going well! Currently, I am experiencing a heavy workload and I have been trying to get all things in order. I've been busy with long term risk management, as well as delving into policies and working alongside our staff to develop plans for services and entertainment to be broadened for our students. Below are some exciting updates, and I encourage you to ask me any questions or concerns you have on any of these.

#### Committees:

#### CSA/GSA Health & Dental Plan Committee

At the Health & Dental Plan Committee meeting on Thursday, October 15<sup>th</sup>, the committee voted to increase our dental plan coverage from \$500 to \$600, while increasing minor restorations from 75% coverage to 80% coverage, at no extra cost to students. This was possible with our surplus accumulated in response to COVID-19 closing dentists across the province, and our insurer agreeing to lower our premiums accordingly. The committee is also looking to begin discussion on the health plan referendum to occur in W21.

#### **Open and Affordable Course Content Task Force**

At the OACCTF, a push for another TextbookBroke survey to determine the financial impact of course materials began, however the University haulted plans, indicating that surveys focused on student wellness were higher priority. Instead, the committee will attempt to include related questions in a survey to be distributed by Wellness so information can still be gathered and reported to the committee.

#### **Energy Conservation Working Group\***

The CSA VP Academic and I attended a presentation in regard to the disbursement of SERF, or

the Student Energy Retrofit Fund. This fund was discontinued in 2019, being replaced by the Sustainability Action Fund that was not charged for Fall 2020. As SERF had a remaining account balance leftover when the fee was discontinued, the Athletics Department is looking for funding from the leftover funds in SERF to support the transition away from natural gas ice resurfacers (i.e. Zambonis) towards electric options that do not rely on fossil fuels and are safer. \*The committee is technically not operational as the SERF has been discontinued, along with its procedures. Instead, the committee formed as of October 22<sup>nd</sup> is acting in place of the Energy Conservation Working Group and includes members as determined by the SERF agreement. The policies in the agreement support this strategy.

#### **SLEF Review Committee (F20 allocations)**

The SLEF Review Committee met on October 23<sup>rd</sup> and 26<sup>th</sup>, reviewing applications to the Student Life Enhancement Fund. The fund was not collected for F20, and instead reserves will be used to fund eligible and accepted applications. As the Guelph Student Foodbank applied, I declared a conflict of interest and was unable to participate in the review of that application.

#### Services:

#### **Guelph Student FoodBank**

The CSA continues to support our Foodbank Coordinator, assisting in contingency planning.

#### **Bullring**

The Bullring continues to operate with takeout only and a reduced menu. A plan to reopen the dine-in services will be submitted to the Office of Student Affairs considering the weather is getting colder, and fewer customers will have places to enjoy their food. We are also examining the possibility of allowing livestreamed events to be held within the Bullring, and this could allow for our CSA Programmer to develop a comprehensive entertainment plan for students for the remainder of F20 and into W21.

#### Other:

#### **Chief Returning Officer**

Interviews for the CRO position will occur this week, hoping to have a hire for November 2<sup>nd</sup>. We will then begin working towards planning for the Winter 2021 election, which will include two *extremely large* referendums which will require an immense effort from all CSA staff, executive, and directors alike.

### Petitions, Delegations, and Representations (PDR)

The PDR Committee will be meeting to review the PDR applications received for the first deadline of October 22<sup>nd</sup>. I chair this committee, and I will provide reports to the Board of Directors once decisions about applications have been made. Eligible applicants may receive up to \$500 as per CSA policies.

### Sara Kuwatly - CSA VP Student Experience: Oct 28th Update

Hi friends! Hope you're all doing well and are staying dry and warm!

Here's some of what I've been up to:

#### Events:

- Sexy Bingo: we had our second Sexy Bingo last night it was co-hosted by Brianna Brexit, a UofG student who does drag. We hosted the event on Twitch, which was our first time using that platform for events. The event was a success and the platform made it really easy to have multiple people on the screen at the same time. Twitch also makes moderating the chat/comments from participants really easy. Moving forward I think we will be using Twitch consistently for our larger events.
- Drag casting call out: I posted the drag casting all out on our social media a couple weeks ago if you know anyone who would be interested/good at it please forward it to them!
- Halloweek: it's been a little challenging figuring out licensing movies to screen at a reasonable price, but I haven't given up yet! On Thursday, October 29<sup>th</sup> we will have a watch party of a prerecorded stunt show followed by a Q&A with Orbax & Pepper.

#### Services:

- SHAC: now that we have a VPA, Sean and I will be co-supervising SHAC. This won't change anything for the SHAC staff, they will treat us as one supervisor to avoid confusion.
- Menstrual Hygiene Initiative: this fee will be suspended for the W21 semester since we have a reserve that will be enough to carry us forward for a little bit.
- Clubs:
  - Accreditation deadline has been extended to October 25!!
  - O I had a very productive and interesting conversation with the Multi Faith Resource Team coordinator Sonya. The team is working on developing a policy that would outline the requirements for new & returning faith-based clubs & organizations on campus. The policy includes the creation of an advisory committee one of its roles would be to advise the CSA clubs office on faith-based & spiritual clubs.

Having previously served as a board member, first for the Student Senate Caucus and as the Campus Co-op's rep., I know the important role that the Board of Directors serves as the CSA's governing body. Despite the challenges that COVID-19 is currently presenting to students, I'm optimistic that the CSA can create lasting improvements to our learning environment derived from the hardships that online learning poses.

#### Committees:

#### Senate

I have not yet been to a Senate Meeting yet. I am taking over these duties from Tyler who assumed them on an interim basis until I was elected. As Tyler previously mentioned in some of his previous updates, a survey went to students who had taken online courses in S20 to determine how the online environment affected learning. Results are of interest to the CSA but were sent to college Deans and not made public. I am currently trying to obtain these results.

#### **Open and Affordable Course Content Task Force**

At the OACCTF, another TextbookBroke survey to determine the financial impact of course materials has been halted based on surveys focused on student wellness being higher priority. There is potential for questions related to course material costs due to financial wellbeing's relationship to overall mental health. This committee will again be meeting on November 2<sup>nd</sup>.

#### **Academic Policies and Procedures Working Group**

We met on Oct. 23rd and discussed potential changes to policies such as the Maximum Weight of Graded Component; policy on Maximum Weight of Single Course Component; policy on Academic Consideration; guidelines for Accommodation; policy on Retaking Passed Courses; calculation of Grade Point Average; policy on Late Adds; limits on Deferrals of Final Exams; and amalgamation of RTW Policies.

#### **Student Rights and Responsibilities Committee**

We met on Oct. 19<sup>th</sup> and discussed penalties for off-campus misconduct. I expressed the opinion that student should not be charged by campus police under circumstances where Guelph City police could also charge them. This could adversely affect students and hold them to a higher degree of responsibility than the rest of the city, even though students have a lower ability to pay their fines based on financial means.

#### **Student Energy Retrofit Fund**

SERF is a legacy fund that no longer collects fees but has funds remaining that require consent from the CSA to be dispensed due to the funds originally coming from students. The athletic department wants SERF contributions to replace their current Zamboni (natural gas) with an electric Zamboni. The CSA president and I met with them on Oct. 24<sup>th</sup> and requested that they provide additional info on GHG abatement quantifications before we consent to funds being dedicated towards this project.

#### **Experiential Learning Ad-Hoc Committee**





We met on Oct. 22<sup>nd</sup> and discussed how students can have their experiential learning experiences recognized and accounted for. Experiential learning is currently something that universities are increasingly promoting due to funding incentives from the Ministry of Universities and Colleges.

#### **Compulsory Fees Committee**

The CFC is meeting on Oct. 29<sup>th</sup> and will be discussing the collection of fees in W21 and ongoing issues stemming from the SCI. We will also be allocating SLEF funding.

#### **Calendar Review Committee**

CRC met on Oct. 15<sup>th</sup>, although I wasn't able to attend (due to still being in transition) and this was attended by the CSA President. We'll be meeting again on November 6<sup>th</sup>.

#### **Student Leaders and Admin Committee**

SLAM met on October 14<sup>th</sup> (although I was not able to attend) and discussed GBSA recommendations as well as student health and safety as it relates to COVID-19. SLAM meets again on the 29<sup>th</sup> and I will be raising the issue of professors not enforcing mask wearing during in person classes, making students feel unsafe.

#### Services:

#### **Student Help and Advocacy Centre**

CSA VPSE Sara will be co-supervising SHAC together for the 2020-2021 term. While this is normally an area that the VP Academic is responsible for, VPSE was supervising SHAC in my absence this summer and we determined that for the sake of continuity it would be most effective for her to continue in this capacity as a co-supervisor of the SHAC staff.

Discussions are ongoing regarding how to better promote the services that SHAC offers in the context of a pandemic. These services continue to be offered online and we are trying to ensure they are more fully utilized. Staff evaluations will be occurring in early November.

#### **EDUCATION FOR ALL**

The national office for the Canadian Federation of Students hosted an "Education for All" workshop to address barriers to accessing post-secondary education on October 21<sup>st</sup>. Our VP Academic and myself attended this workshop which covered discussion topics such as COVID-19 financial challenges, accessibility concerns with online learning, rising tuition fees, systemic barriers to accessing post-secondary education, and the necessity of students' rights to independently organize. This campaign is calling for lower tuition fees, more grants and free education for all. #### **FUTURE MAJORITY**

Future Majority is a campaign that aims to get the youth politically involved for a post-pandemic recovery that is green and just. I attended a meeting with the organizers of this campaign on October 15<sup>th</sup> and hope to work alongside this group to further engage our membership with this campaign.

#### d. Election Dates & Results

CSA By-Election took place from September 14<sup>th</sup> to October 1<sup>st</sup>. Candidate nominations took place from September 14<sup>th</sup> to 18<sup>th</sup>. #### a. Education for All

CSA has been campaigning around the Education for All campaign, and has been using CFS campaigning materials to have conversations around the state of Post-Secondary Education during the COVID-19 pandemic. COVID-19 has presented students, workers, staff, faculty, and TAs with several different challenges. On September 18<sup>th</sup>, CSA hosted an Online Forum (in collaboration with the International Students Organization and OPIRG) discussing student concerns around the digital Post-Secondary experience. These conversations included financial barriers to education, accessibility concerns, academic issues, mental health challenges, etc. As a result, the CSA extended these conversations to include concerns from workers unions, professors, TAs and Sessional lecturers. We continue to solicit student input/testimonies/experiences as we move forward with our advocacy efforts.

#### b. United for Equity

CSA operates under and Anti-Oppressive Mandate and aims to challenge oppression on campus. The CSA has been working closely with the Guelph Black Students Association (GBSA) to challenge anti-black racism on our campus. Throughout the summer semester, CSA and GBSA collaborated to send care kits to Black students. We also hosted a "Digital Speaker Series: Amplifying Back Voices" and chatted with GBSA executives about their letter to the University of Guelph administration on supports that are lacking for Black students and how we can collectively do better. This year CSA hopes to build stronger relationships with the special status organizations across campus.

#### e. Fairness for International Students

CSA and the International Students Organization (ISO) wrote a statement to the University of Guelph demanding an immediate reversal of the tuition fee increases, freeze on tuition fees, and more financial supports for international students. Along with this statement, CSA, ISO, and CFS created an emailer tool on our website that allows students to send letters to the University of Guelph administration with the demands mentioned in our statement. Our international students continue to struggle, as the university refuses to meet our demands in full. Partial financial aid has been provided to students, but this aid is very minimal in comparison to the 10 to 15 percent tuition fee increases the institution implemented at the beginning of the summer semester.

#### 4. POST-SECONDARY EDUCATION ISSUES

#### a. COVID-19 Pandemic

COVID-19 has presented CSA with several challenges. The University of Guelph has been implementing strict guidelines around in-person events and physical presence on campus. As a result, some of our services are not able to operate or do so at a limited capacity. Advocacy and campaigning is also not the same in with the virtual formats, but this is where we have to get creative!

#### 5. MEMBERSHIP DEVELOPMENT

#### a. Implementation of Federation's Membership Awareness Strategy

CSA continues to re-share any content the Federation posts on social media and invites CFS representatives to any campaigning initiatives/events to ensure students are aware that CSA is a member of the Federation. We are also hoping to have CFS Ontario give a presentation to our CSA Board about the Federations services and advocacy.

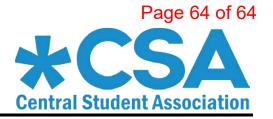
