I want all the groups to come together, allow them to share resources, ideas, and goals, and updating the great work and sustainability initiatives that are taking place across campus. Another group, meeting tomorrow, is the Racialized Students Constituency. This group is a safer space for racialized students to share experiences at Guelph and work to make campus more inclusive. We will be focusing on cuts to OSAP, grants/loans; I have been tabling and some stories hearing from our students are really disheartening, so I want to bring the stories to the forefront. If anyone wants to be involved, feel free to reach out to me. Or if you have your own personal story or have been impacted, please let me know. I know some of my grants are now being turned into loans, so it's not an uncommon thing, for people who have already graduated are getting these emails.

The Board of Governors did take place on January 22 and I hand-delivered the letter to the Chair and the University President, letting him know we will continue to pressure the university until they divest fossil fuels. I encourage you to share similar letters; it would be nice if the University can start feeling pressure from student organizations. We need to work towards divestment, other universities have made commitments, and Guelph can and will be a leader in divestment.

Thibeca Kengatharan: My name is Thibeca and I am your Clubs Administrative Coordinator. I am responsible for any accreditation that happens or club conflict that may occur. I work in the office with Yeva, who is our Clubs Programming Coordinator, and she primarily does events and Student Event and Risk Management approval, so SERM. We have over 120 clubs that operate through the

CSA office; it's a very busy and fun office. We have the clubs hallway, second floor of UC. We have five meeting rooms, CSA clubs have priority to book the space. We have the club lounge, we have a comfort room, lockers, poster room, which is all accessible to clubs, and we have open access to meeting rooms between 8 am and 11 pm, Monday through Friday. Our semester is really busy with Clubs Days. They run two days in the UC courtyard, a highly attended event, a lot of need for spots. We make sure we are giving first priority to CSA clubs before reaching out to other clubs. Because of such a high demand last semester, we didn't want to turn people away. So we extended Club Days into the UC balcony, but we didn't find it that effective, not a lot of traffic. We didn't do it this semester because there are less clubs in the winter semester compared to the fall.

To be a club, you need to be accredited through the CSA. In the fall semester, the accreditation deadline was October 27 and through the Clubs Tribunal, which has the approvals, and the CSA VP Student Experience, we were able to accredit 122 clubs, including 14 that were new clubs. This semester, we have accreditation coming on February 14. It's just for new clubs or anyone returning that wasn't able to last semester. We are expecting ten new clubs and maybe two returning, so it will be fun to see those new initiatives on campus. To become accredited as a club, one member from the club needs to attend the Clubs General Meeting, where we have SE&RM training and anti-oppression training. This just makes sure that clubs have the tools they need to run events in an anti-oppression manner. A Student Event and Risk Management form needs to be completed on GryphLife. Our coordinator and CSA VP Student Experience approve or deny any SE&RM events; this just ensures that CSA is informed with all events and any risks happening and under CSA insurance. Moving forward, we are working heavily on transition, to ensure our incoming executive for next year are equipped for everything they need. This is thinking about Fall 2020 right now.
